


Question: Have you applied professional ethical values during the activity?

A grievance cell for female students should provide a safe and confidential space for voicing concerns related to harassment, discrimination, and other issues. It should include trained counselors, a clear reporting mechanism, and regular follow-up support to ensure that students feel heard and supported. Additionally, awareness programs and staff training on sensitivity and legal issues are essential for fostering a positive environment and encouraging open dialogue.


