STUDENTS GRIEVANCE REDRESSAL SYSTEM

For internal examinations

Within a given time frame, the person in charge for the subject assesses the answer sheets, which are then displayed to the students to look for any discrepancies. The evaluation and marking process are explained to the students. Students must sign the answer sheet that has been examined. If there are any questions, the subject-matter expert will answer them and, if necessary, make the necessary corrections. If student is not satisfied with clarification, there is provision to refer it to Examination Department to be solved by senior faculty, HOD and Principal. After solving queries of students, the marksheet of internal sessional examinations is displayed on notice board. Students confirm their scores for the internal sessional test by signing a bound register, and the institution is informed of this.

For External examinations

Students may request photocopies of their courses after the university results have been announced if there is any disagreement in the results of any topic. SPPU provides photocopies to students. Senior faculty or the HOD are shown the photocopy to allay their fears, and if necessary, they can then submit an application to the University for Reevaluation. The university announces the results following reassessment.


