#### 2. Event Highlights:

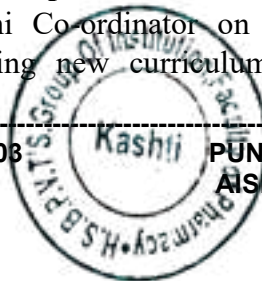
The event featured a series of presentations, speeches, and interactive sessions designed to foster engagement and knowledge-sharing among alumni, faculty, and current students.

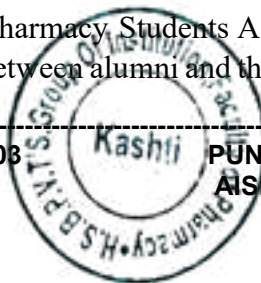
### 5. Conclusion:
