CIRCULAR

Attendance Requirement for Sessional & University Examinations

All students are hereby informed that **minimum 75% attendance is essential** for appearing in the sessional examinations and for fulfilling the eligibility requirements for University examinations.

Students are instructed to attend the college regularly and maintain the required attendance throughout the semester. The remaining **25% permissible absence** should be utilized judiciously for unavoidable circumstances such as **illness, family functions, personal emergencies, travel, etc.** Students should not consider this 25% as regular leave entitlement.

Students are further advised to plan their personal commitments in such a manner that their academic attendance is not affected. **Marriage during the course may make it difficult to maintain regular attendance and complete academic requirements. Therefore, students are strongly advised to complete their course before getting married.**

This is a **full-time professional course** requiring regular attendance, practical work and academic engagement. Students are therefore **not permitted to undertake regular employment/job while pursuing the course**, as employment may adversely affect their attendance and academic performance.

Important Instructions

1. Students having **less than 75% attendance will not be permitted to fill the University Examination Form.**
2. Students having less than the prescribed attendance may also **not be permitted to appear for sessional and University examinations**, as per applicable University and regulatory rules.

2. Semester VII students who are not undertaking an internship during the First Sessional Examination period and have attendance below 75% will NOT be permitted to appear for regular sessional examination and the resessional Examination.
3. There will be no Second Resessional Examination under any circumstances. Students are therefore advised to maintain the required attendance and appear for the examinations as scheduled.
